1. Upon receiving your license from the Arizona Department of Real Estate or Appraiser Board, complete the Application for REALTOR® Membership. Your Designated REALTOR® must sign this form before you can join and be issued a Supra Key. **A new one-time Office Application Fee is an additional \$200.00.**

2. **IF you are a new agent, or an agent using something other than FLEX you must attend the SAMLS Orientation Class.** There is no charge for these classes; however, you must complete the requirements within one hundred twenty (120) days of joining SAMLS. Your SAMLS membership is conditional until you complete these requirements. **Failure to attend the required courses within the specified time (120 days) will result in forfeiture of application fees and your membership will be terminated.**

3. All MLS Fees are billed to your Broker on an annual basis in the amount of \$576.00 with the fiscal year being July-June. The fees are prorated on a monthly basis. At the time of Application, current fees must be paid.

I further agree that my act of paying dues shall evidence any initial and continuing commitment to abide by the aforementioned Code of Ethics, Constitutions, Bylaws, Rules and Regulations, and duty to mediate, all as from time to time amended. Finally, I consent and authorize the MLS, through its membership committee or otherwise, to invite and receive information and comment about me from any member or other person, and I agree that any information and comment furnished to the MLS by any member or other person in response to any such invitation shall be conclusively deemed to be privileged and not form the basis of any action by me for slander, libel, or defamation of character.

Applicant acknowledges that the MLS will maintain a membership file of information which may be shared with other boards/associations where applicant subsequently seeks membership. This file shall include: previous applications for membership; all final findings of Code of Ethics violations and violations of other membership duties within the past three (3) years; pending complaints alleging violations of the Code of Ethics or alleging violations of other membership duties; incomplete or pending disciplinary measures; pending mediation requests; and information related to unpaid mediation awards or unpaid financial obligations to the board/association or its MLS.

Applicant acknowledges that if accepted as a member and he/she subsequently resigns from the MLS or otherwise causes membership to terminate with an ethics complaint pending, the Board of Directors may condition renewal of membership upon applicant's certification that he/she will submit to the pending ethics proceeding and will abide by the decision of the hearing panel. If applicant resigns or otherwise causes membership to terminate, the duty to submit to mediation continues in effect even after membership lapses or is terminated, provided the dispute arose when applicant was a REALTOR®.

NOTE: I also agree to attend the Code of Ethics class as mandated by NAR & SAAR every two (2) years. I also acknowledge this training is a condition of membership.

I hereby certify that the foregoing information furnished by me is true and correct, and I agree that failure to provide complete and accurate information as requested, or any misstatement of fact, shall be grounds for revocation of my membership.
